BANKING SECTOR SUMMARY

The Banking index lost 2.104% m/m in May, underperforming the ASI by 605bps due to sell offs across the sector. Despite the release of Q1 financials with fairly positive results, investors exited the sector in favour of Oil & Gas (+5.29% m/m) and Consumer Goods (+5.44% m/m). The likes of GTCO, UBA, ZENITHBANK, FCMB and FIDELITYBK were marked down for dividend payments, which contributed to the price drops.

This month, we anticipate some cherry-picking action on stocks that are likely to pay interim dividends, while investors may choose a wait and see approach due to the varied fortunes of banks so far this year. With yields in the Fixed Income market rising after the recent MPC decision, as well as rising political uncertainty, the possibility of further drops in banking stocks is heightened and we foresee mixed trading in the sector in the near to medium term.

INDEX DESCRIPTION


