FUND DESCRIPTION

The Vetiva Banking ETF "VETBANK ETF" is an open-ended Exchange Traded Fund managed by Vetiva Fund Managers Limited. The VETBANK ETF is designed to track the performance of the constituent companies of the NGX BANKING Index and to replicate the price and yield performance of the Index.

INDEX DESCRIPTION

The NGX BANKING Index comprises of the top 10 banks listed on the Nigerian Exchange Group ("NGX") in terms of market capitalization and liquidity and is a price index weighted by adjusted market capitalization.

MARKET REVIEW & OUTLOOK

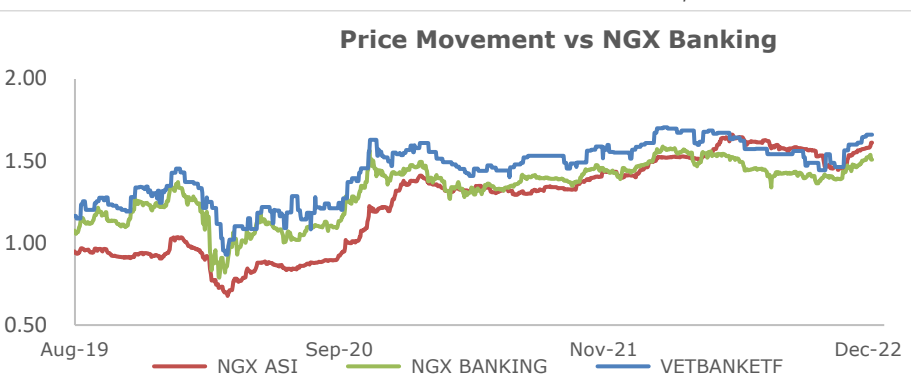
The Banking Index closed at a positive position in December as this sector contributed to the gains recorded by the NGX in December. The interest in the Banking sector continued its momentum, however the renewed interest in the Oil and Gas and Consumer Goods sector contributed to the drop in the banking index by 84.92% m/m. ZENITHBANK and GTCO and drove the performance of the sector in December, surging by 14.75% and 17.09% m/m respectively.

We expect less trading of banking stocks as investors interest moves away from the banking sector to other sectors. While we expect overall sentiment to be bearish in January, we believe investors will engage in cherry-picking on fundamentally sound stocks with attractive dividend yields, which would favor some counters, especially in the banking sector.

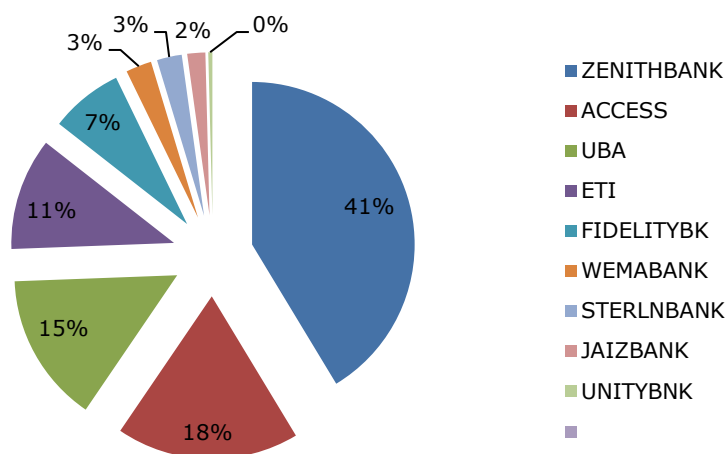
