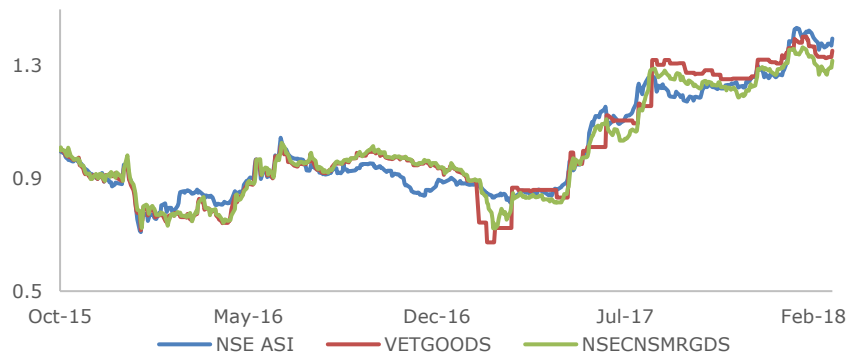
### INDEX DESCRIPTION

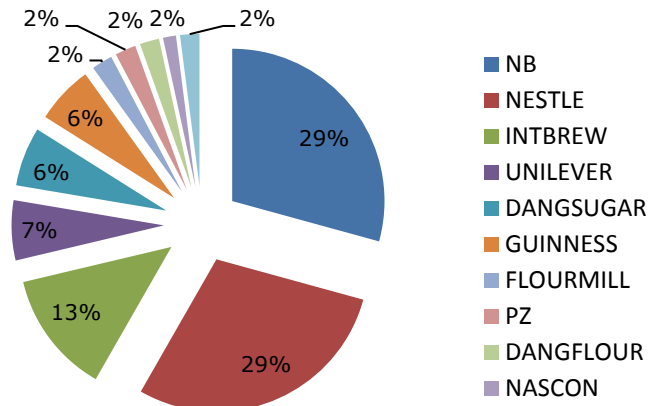
