INDEX DESCRIPTION

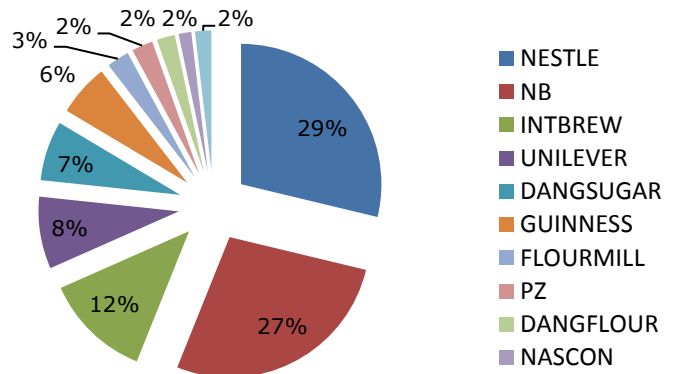
