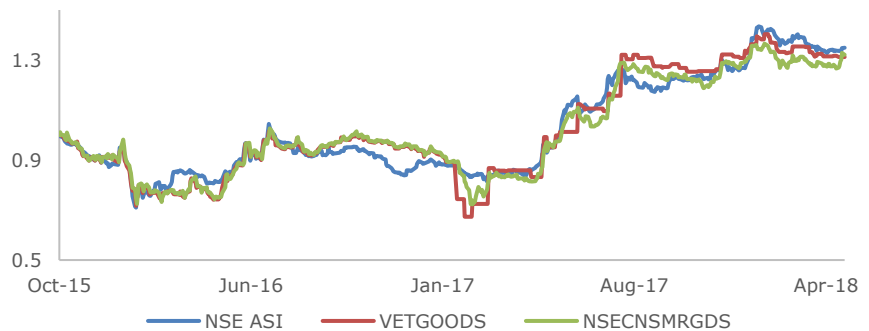
INDEX DESCRIPTION

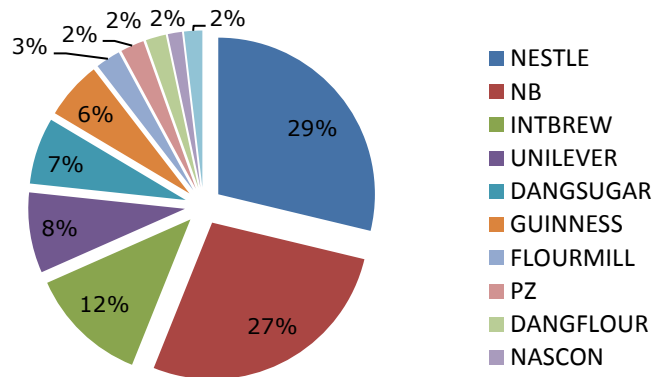
