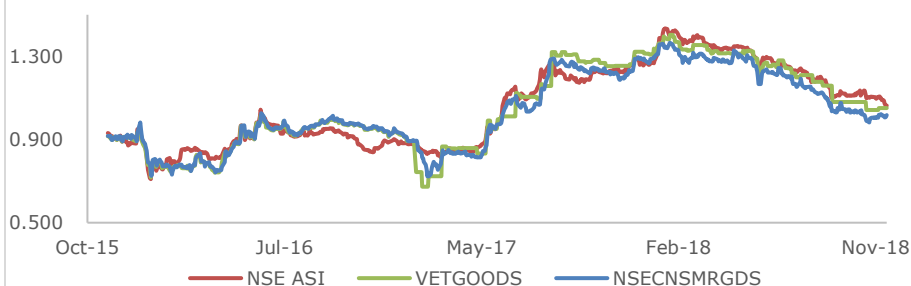
INDEX DESCRIPTION

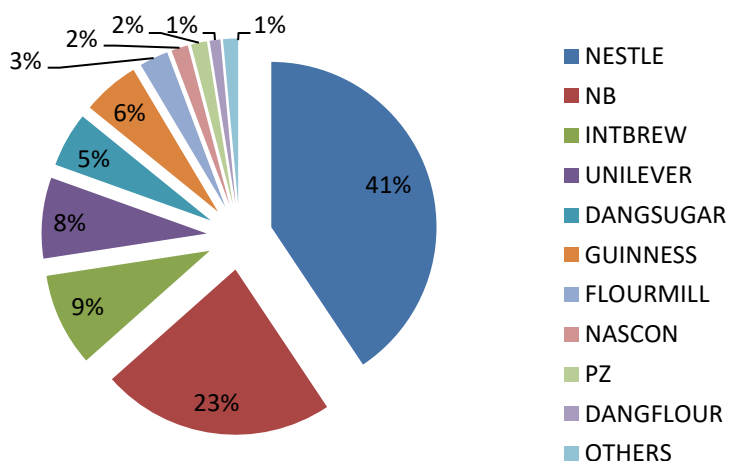
