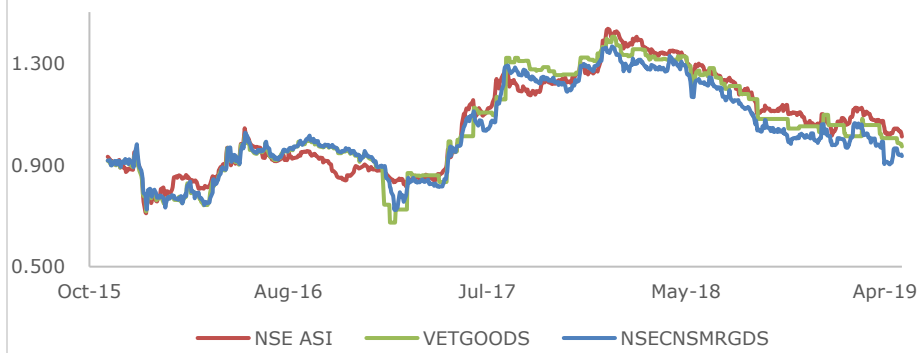
INDEX DESCRIPTION

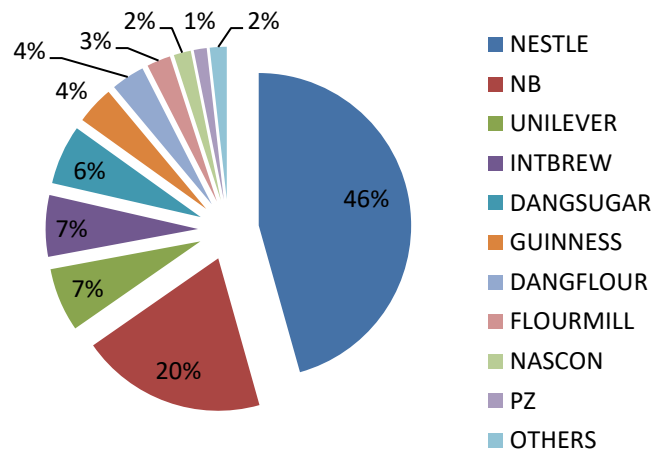
