INDEX DESCRIPTION

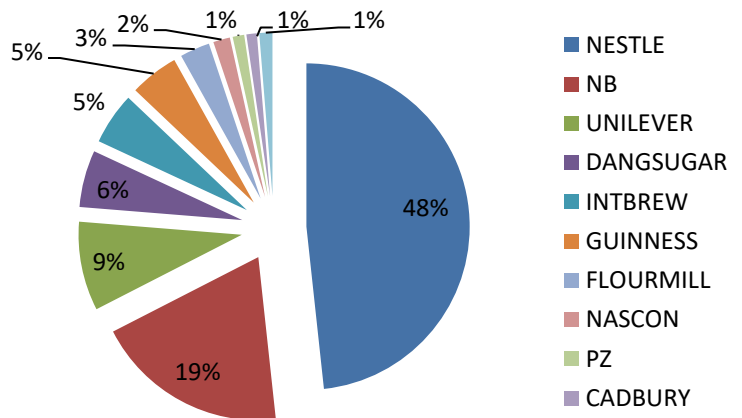
