### FUND DESCRIPTION

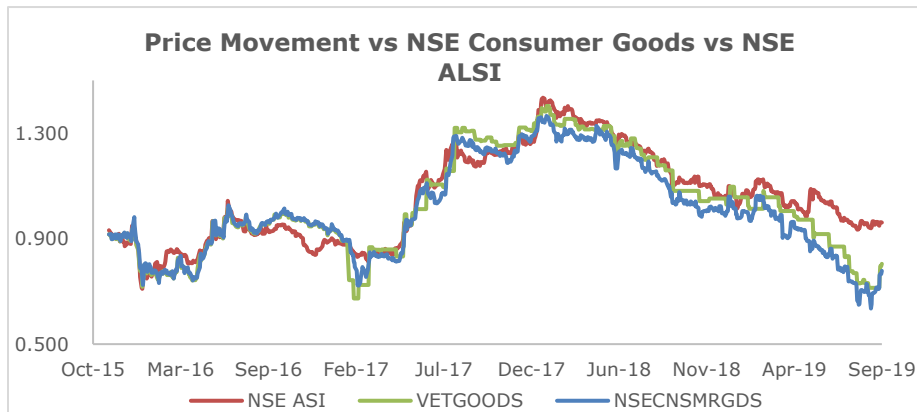

### INDEX DESCRIPTION

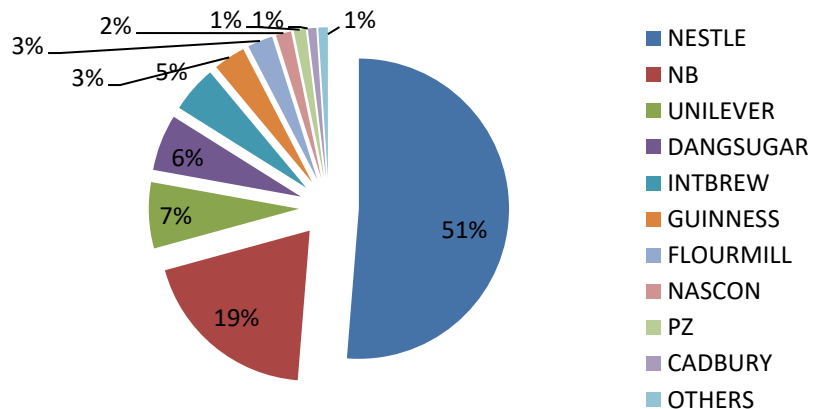
