### INDEX DESCRIPTION

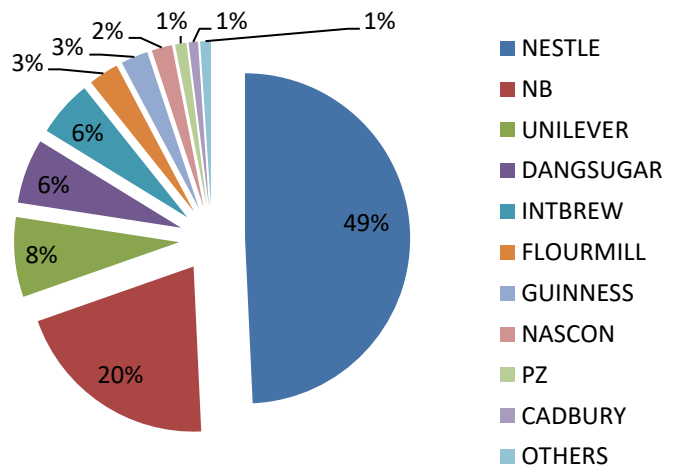
