FUND DESCRIPTION

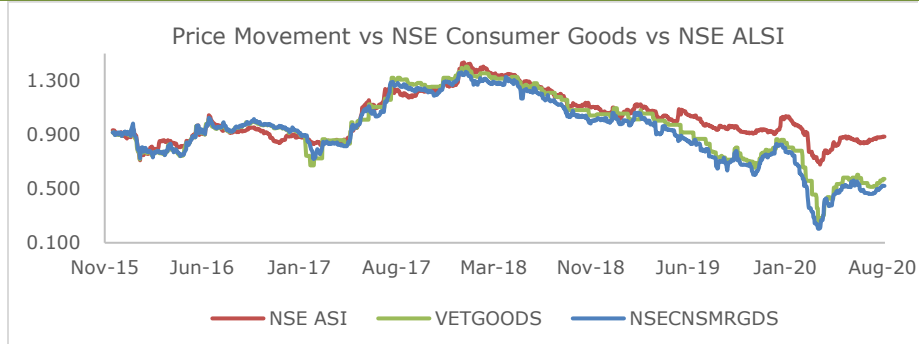

INDEX DESCRIPTION

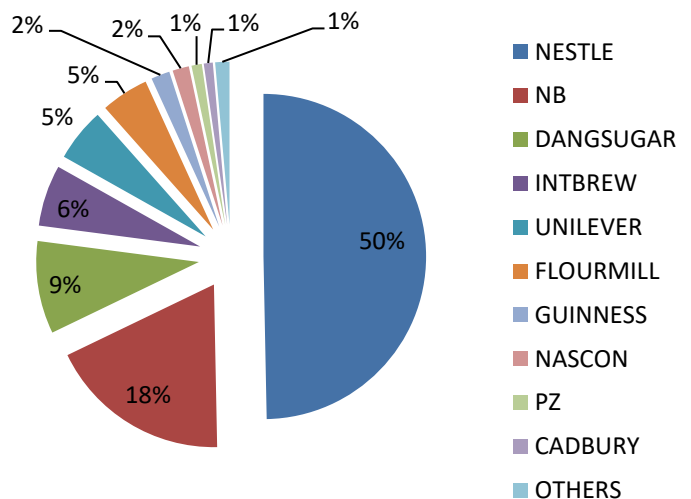
