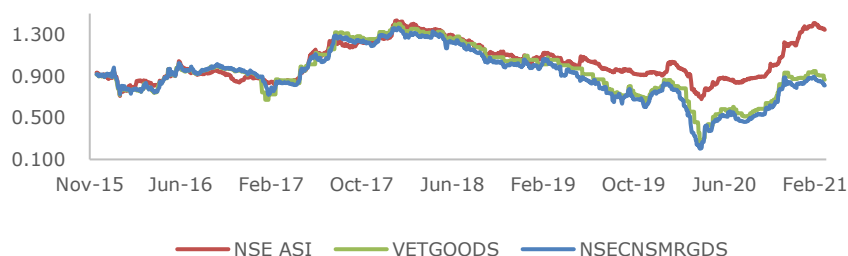
INDEX DESCRIPTION

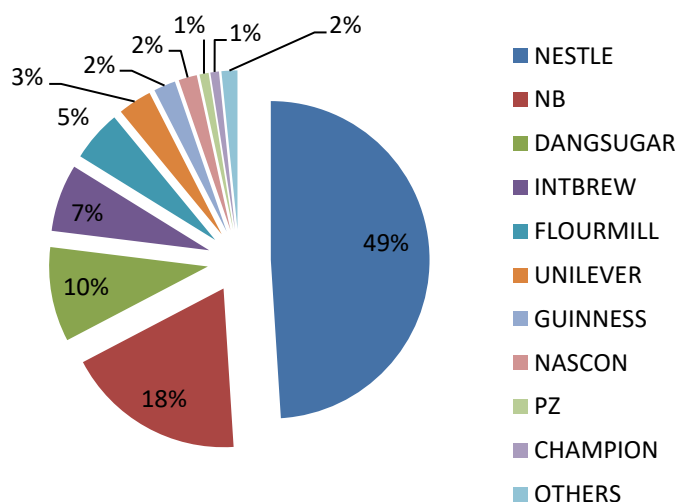
