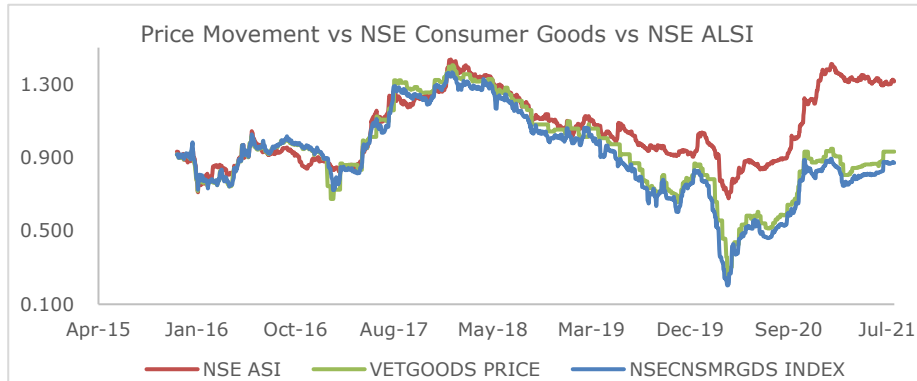

INDEX DESCRIPTION

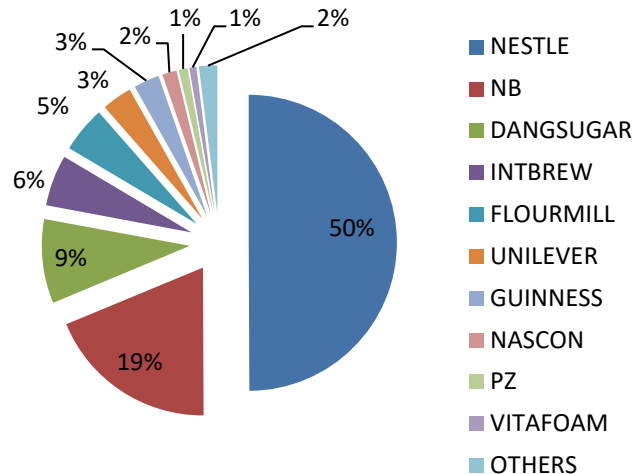
