#### **FUND DESCRIPTION**

The Vetiva Consumer ETF "VETGOODS ETF" is an open-ended Exchange Traded Fund managed by Vetiva Fund Managers Limited. The VETGOODS ETF is designed to track the performance of the constituent companies of the NGX Consumer Goods Index and to replicate the price and yield performance of the Index.

#### INDEX DESCRIPTION

The NGX Consumer Goods Index comprises of the top 15 companies in the Food/Beverages and Tobacco sector listed on the Nigerian Exchange Group ("NGX") in terms of market capitalization and liquidity and is a price index weighted by adjusted market capitalization.

#### **MARKET REVIEW & OUTLOOK**


The All-Share Index (ASI) closed in negative territory in March, losing 1.99% month-on-month (m/m), with the ASI closing the month at 105,670.36 points resulting in a YTD gain of 2,67%.


Narrowing down to the Consumer Goods Sector, the index closed in negative territory with a loss of 1.30% m/m driven by a bearish run in INTBREW (-3.77%), NB (-2.01%) CADBURY (-10.46% m/m), DANGSUGAR (-17.25% m/m) and HONEYFLOUR (-9.85% m/m). Although large cap BUAFOODS remained flat month-on-month, we saw stocks like GUNNESS (+8.11%) and NASCON (+1.66%) close in the green.

Despite the weak performance in March, we note that the Consumer Goods sector remains one of the better performing sectors on the Exchange and returned 4.86% in Q1'25, above the 2.67% return for the broader market. Nonetheless, we expect sentiment for this sector to remain largely lukewarm as corporate releases roll out given that the sector remains on a path to steady growth following severe macro headwinds that disrupted earnings accretion.
