INDEX DESCRIPTION

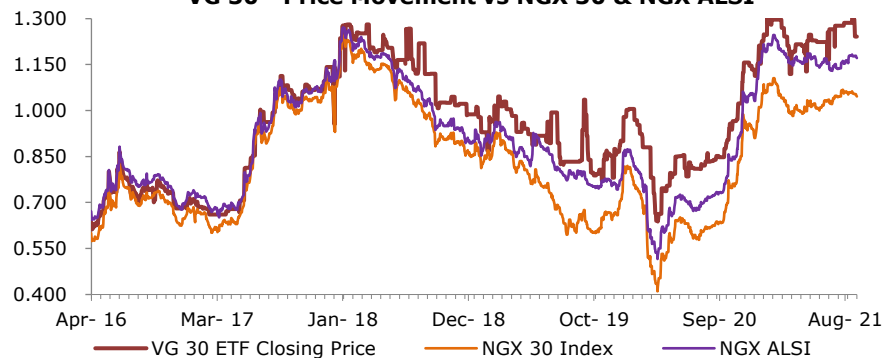

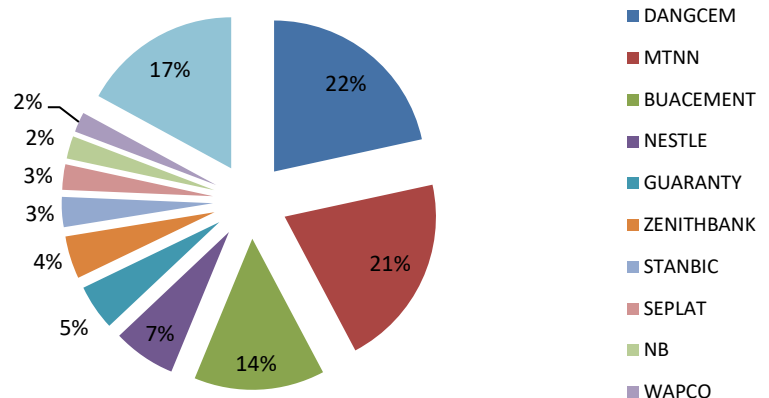
