FUND DESCRIPTION

The Vetiva Griffin 30 ETF "VG 30 ETF" is an open-ended Exchange Traded Fund managed by Vetiva Fund Managers Limited. The VG 30 ETF is designed to track the performance of the constituent companies of the NGX 30 Index and to replicate the price and yield performance of the Index.

INDEX DESCRIPTION

The NGX 30 Index comprises of the top 30 companies listed on the Nigerian Exchange Group ("NGX") in terms of market capitalization and liquidity and is a price index weighted by adjusted market capitalization.

MARKET SUMMARY

In the first quarter of 2023, investors were largely positive on the Nigerian market, evidenced by the 6.24% q/q return of the NGX30. This was driven by strong positive sentiment as the year opened amidst cautious optimism ahead of the election season and general improvement in sentiment towards fundamentally attractive stocks listed across key sectors on the Nigerian Stock Exchange. The index constituents are spread across various sectors Banking, Consumer, Industrial, Agriculture and Oil & Gas, with the Telecommunication sector being the largest sector.

In terms of individual companies, AIRTELAFRI, DANGCEM, MTNN and BUACEMENT are the most capitalized companies in the NGX 30 Index, with the 4 companies accounting for over 64.30% of the total weights.

Looking ahead, investors will focus on Q1'23 earnings results to guide their investment decisions in the NGXASI. Although the overall outlook remains mixed, recent macroeconomic indicators suggest that the economy remains resilient despite higher interest rates and marginally weaker global oil prices. Furthermore, the Central Bank's ongoing interest rate decisions and their impact on the broader economy will continue to be a significant focus for investors. So far in April, we have seen the market pull back significantly (MTD: -3.68%) and wiped off some of the gains earlier recorded in the year as investors took profit on counters across the Telecommunications and Banking sectors especially.


