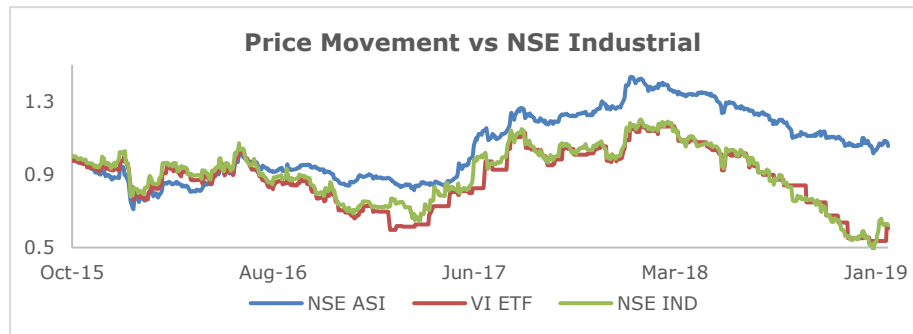

INDEX DESCRIPTION

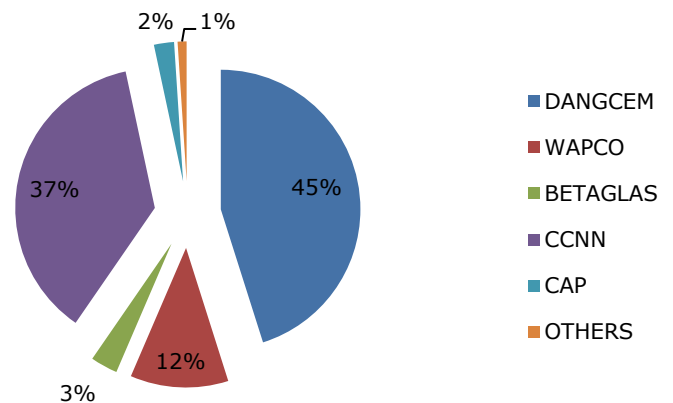
