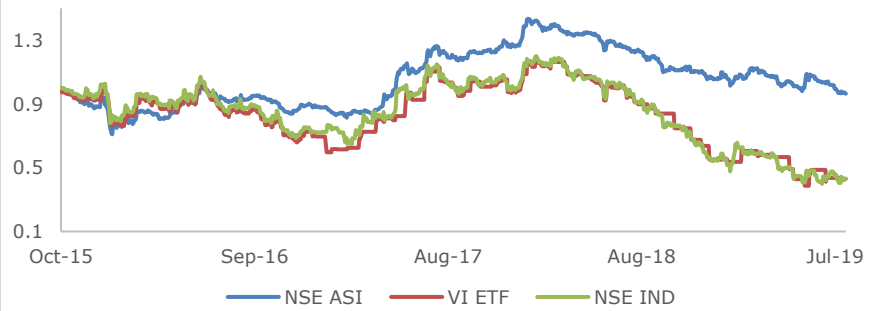
INDEX DESCRIPTION

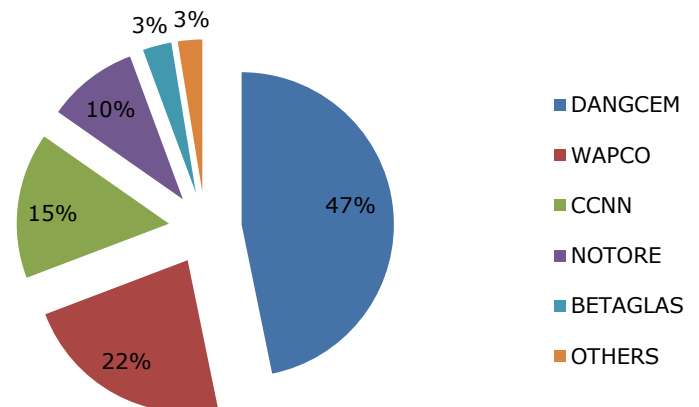
