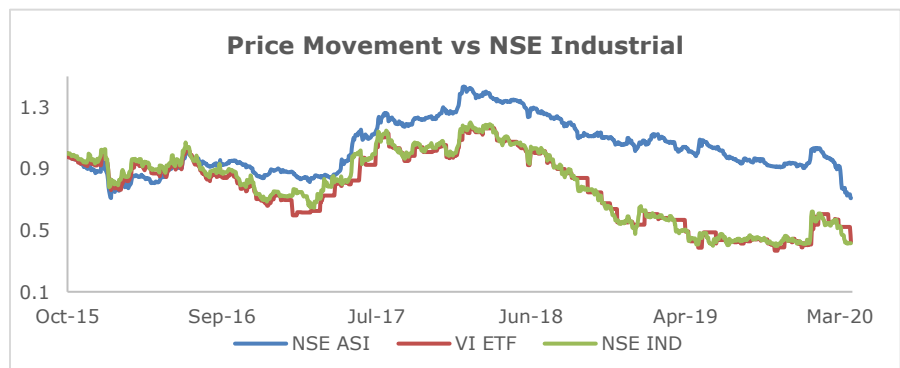

INDEX DESCRIPTION

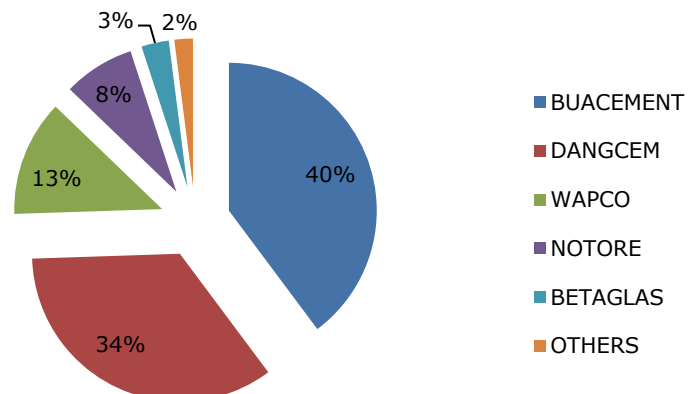
