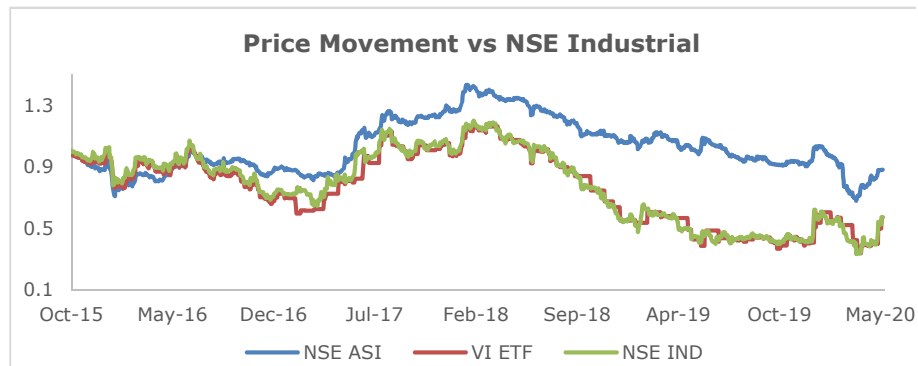

INDEX DESCRIPTION

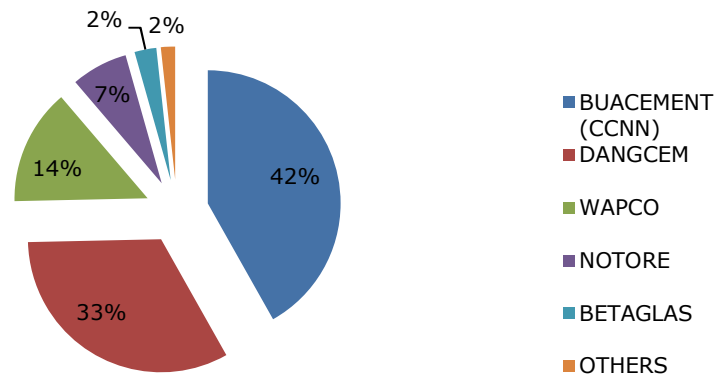
