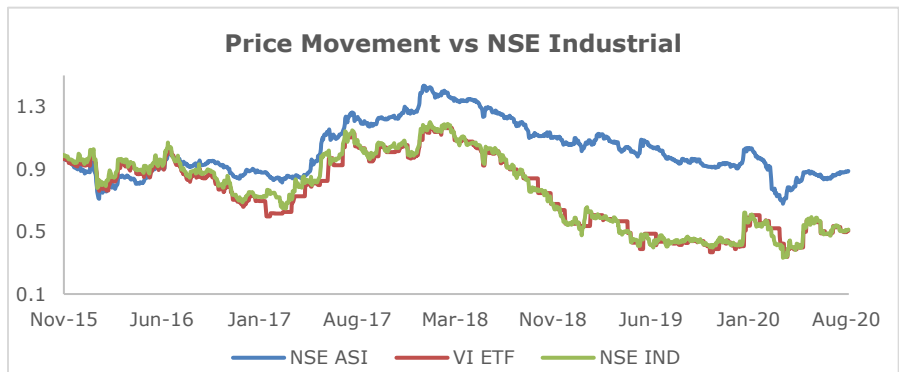

INDEX DESCRIPTION

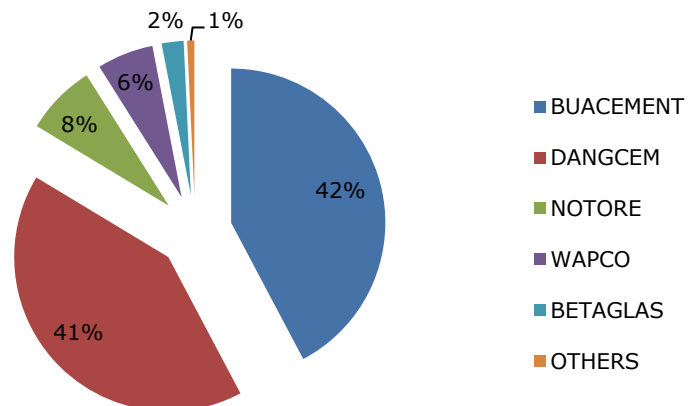
