The NGX Industrial Index comprises of the top 10 companies in the Industrial sector listed on the Nigerian Exchange Group ("NGX") in terms of market capitalization and liquidity and is a price index weighted by adjusted market capitalization.

MARKET REVIEW & OUTLOOK

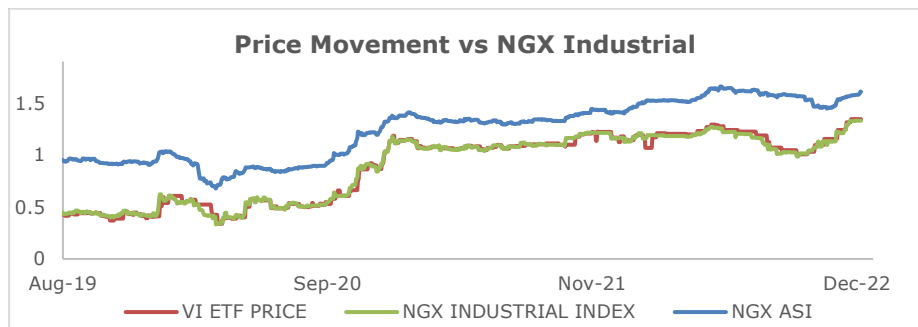
The Industrial Goods Index recorded little activity in December, which had a little effect on the performance of the NGX in December. The index rose by as the Industrial Goods index rose by 0.14% m/m. WAPCO AND BUACEMENT drove the performance of the sector in December, surging by 6.59% and 26.95% m/m.

Going forward, with global central banks, including the CBN taking a hawkish stance against inflation, further rate hikes by the MPC could significantly impact the equities space, making Fixed Income yields more attractive. Consequently, we expect continued bearish sentiments in the equities market in the coming month.

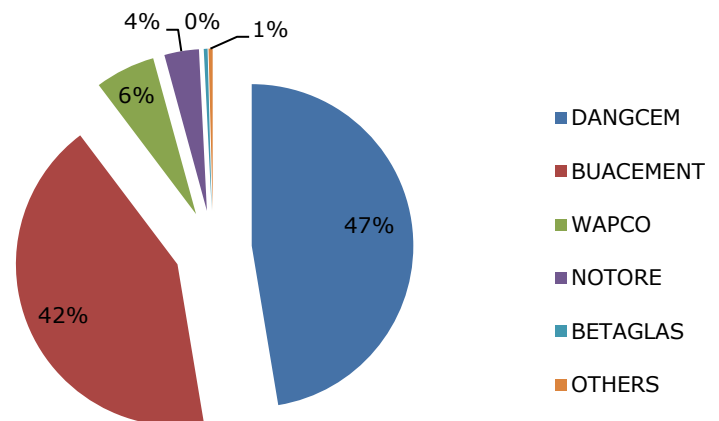
