INDEX DESCRIPTION

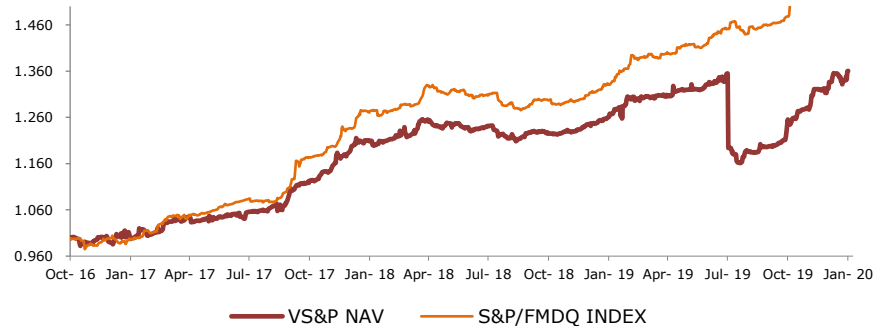

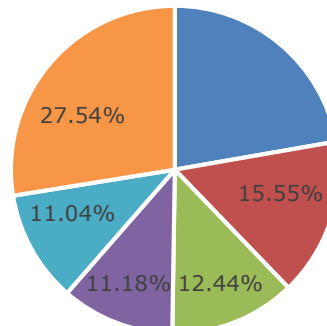
