

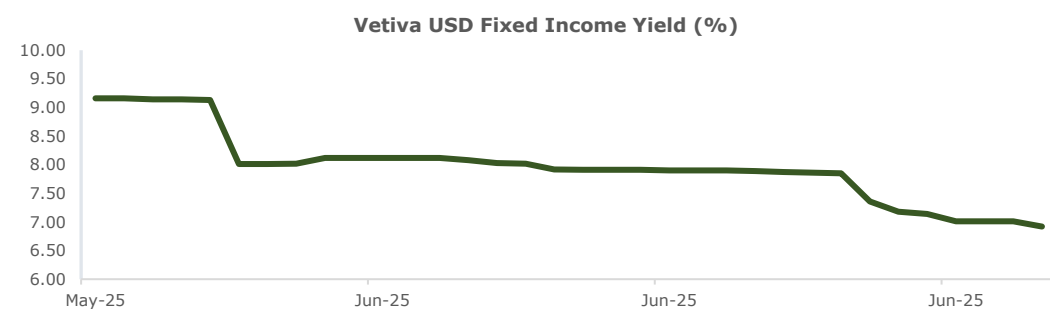

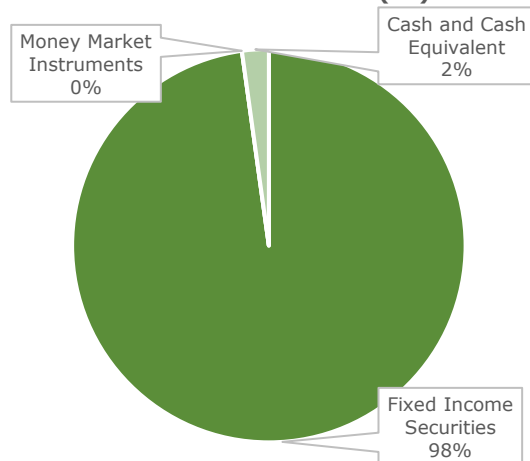

FUND SUMMARY

The Vetiva USD Fixed Income Fund ("VUFI") is an actively managed open-ended Fund that invests in a variety of high-quality fixed income and money market securities like Nigerian Sovereign Eurobonds, Corporate Eurobonds, Multilateral Eurobonds and other short-term USD money market instruments.

INVESTMENT OBJECTIVE

The fundamental objective of VUFI is to efficiently generate and maximize income in Dollar terms whilst providing liquidity, diversification and competitive returns within an acceptable level of investment risk in the medium to long term through investments in US dollar-denominated fixed income assets.

INVESTMENT STRATEGY

VUFI operates by pooling funds from multiple investors and strategically investing them in a diversified portfolio of fixed income and money market instruments. The selection of securities for the Fund is driven by a detailed investment policy underpinned by the Fund Trust Deed.

INVESTOR SUITABILITY

The Fund is targeted toward prudent investors (retail, High Net-worth individuals and Institutions) looking to maximize interest income in short to medium-tenured USD securities.

HOW TO INVEST IN THE FUND

MARKET COMMENTARY & OUTLOOK

REVIEW:

In the Eurobonds market, investors preferred to remain cautious due to global market uncertainties emanating from the US tariff trade wars, middle- eastern tensions, and ongoing war between Russia and Ukraine. Sell side pressures were persistent across the Nigerian Eurobonds curve with the average yield remaining elevated, settling around 8.27% at the end of June. This resulted from weaker oil prices and general global market uncertainty which caused investors to seek out safe-haven assets like US treasuries and commodities like Gold and dump emerging market assets like Nigerian Eurobonds.

For July 2025, we expect market factors like global inflation, oil prices and easing middle eastern tensions to guide market activity while investors weigh the impact of the US trade tariffs on the global economy.

On the end of the portfolio, we deployed funds invested in this recently launched Fund in Fixed Income Securities, i.e. Sovereign Eurobonds and Corporate Eurobonds, and took advantage of attractive Eurobond prices as practicably as possible. As at 30th June, the average coupon and yield on the fund stood at 8.55% and 7.94% respectively.

We intend to take continued advantage of investments with approved counterparties on favorable terms to enable quick allocation of fresh funds as the Fund continues to grow in subsequent quarters. Overall, we would continue to ensure the competitive return of the Vetiva USD Fixed Income Fund for the benefit of the unitholders.
